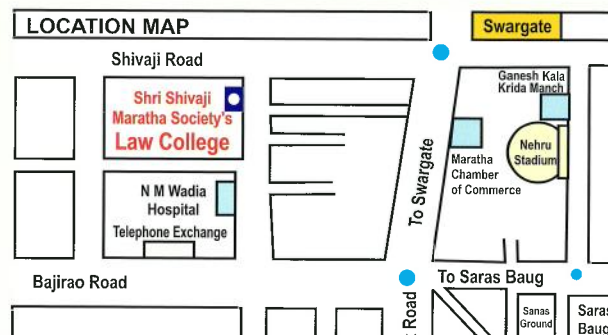
Guest Lectures of the Year (2021-2022)
