- ◆ Our College Team was awarded the Best Memorial Award at Angel School of Law, Mumbai.

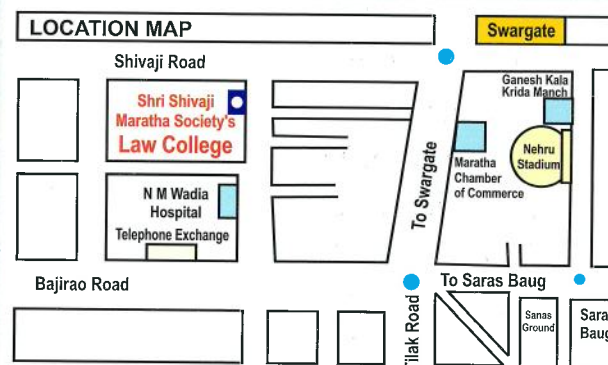
