MOOT PROBLEM

The State of Karnakat is one of the most populous States in the Republic of Indican. The town of Navagram, located in the southern part of Karnakat. On December 12, 2023, a well-known forensic pathologist, Dr. Akarsh Mehta, was conducting an autopsy at the Navagram Government Hospital when he discovered that the body of Ms. Prisha Rao, a 24-year-old woman who had been found dead under suspicious circumstances, showed signs of sexual activity post-mortem. Subsequent forensic examination confirmed the presence of seminal fluids and DNA belonging to Mr. Rishabh Verma, a mortuary assistant working at the same hospital.

Following the investigation, Rishabh Verma was arrested and charged under Section 297 Indican Penal Code 1860, at present under Section – 301 Bharatiyana Nyaya Code, 2023, for trespassing on a burial site and violating the dignity of a dead body, Section 377 of the former Indican Penal Code 1860 is deficient about the same. However, the prosecution faced a significant legal challenge as the Old Law Indican Penal Code 1860 and now Bharatiyana Nyaya code, 2023, which does not explicitly recognize Necrophilia as a Criminal offence, nor does it provide for post-mortem sexual assault under the definition of "Rape" under Section 63 of Bharatiyana Nyaya code, 2023.

The accused, Rishabh Verma, through his counsel, argued that his actions do not constitute Rape as the Law requires the victim to be alive at the time of the act. Furthermore, he contended that there was no express provision criminalizing Necrophilia. On the other hand, the State of Karnakat argued that the act of sexual assault on a deceased person violates the Fundamental Rights of dignity under Article 21 of the Constitution of Indica and demanded urgent judicial intervention to fill the Legislative gap. The prosecution also argued that Section 375 and Section 376 with Indican Penal Code 1860 and at Present Section 63 of Bhartiyana Nyaya Code, 2023, should be interpreted expansively to include post-mortem assault within its ambit, emphasizing the need for judicial recognition of the inherent dignity of the deceased. The High Court of Karnakat reversed the decision of the Trial Court and acquitted the accused of all offences. The High Court ruled that post-mortem sexual assault does not constitute Rape or any other recognized sexual offence under the existing legal framework.

Being aggrieved by the order passed by the High Court of Karnakat, the aggrieved party moved to the Supreme Court of Indica to challenge the order of the High Court of Karnakat. It raised fundamental legal and constitutional questions regarding the scope of Rape Laws, the Right to dignity of the dead Person, and the necessity of Legislative Intervention in criminalizing Necrophilia.

Issues for Consideration:

1. Whether the definition of "Rape" under Sections 375 and 376 Indian Penal Code, 1860 as well as at present Section 63 of the Bharatiya Nyaya Code, 2023, should be expanded to include victims who are deceased at the time of the offence.
2. Whether post-mortem sexual assault should be classified as Rape, an Unnatural Offence, or necessitate recognition as a distinct criminal offence under Indian Law.
3. Whether the gravity of the concept of dignity with respect to sexual activity with a deceased person violates the constitutional guarantee of dignity under Article 21 of the Constitution of India.
4. Whether a dead body can be considered a 'Person' under the Law and whether the absence of explicit statutory provisions criminalizing 'Necrophilia' in India creates a Legal Vacuum.
